General booking and rental conditions

1. The rental is made on a strictly personal basis. The tenant may under no circumstances sublet his location with the equipment he has reserved.
2. Rentals are from Saturday 3 p.m. to Saturday 10 a.m.
3. The dates listed on the contract must be respected, early departures will not be refunded.
4. In case of delay, please let us know. The reservation remains at your disposal for 24 hours (unless agreed by the management), but the full amount of the stay will be due. After this period, the management may dispose of the rental. Payments paid will be retained.
5. Each person present on the campsite must respect the rules of procedure displayed at the entrance and in front of the reception desk.
6. Smoking is prohibited in the rentals.
7. Visitors must park their vehicles outside the grounds. (Exemption for people with reduced mobility after agreement of the management)

Deposit and inventory

1. A deposit of 300 euros will be requested on your arrival and returned at the end of your stay subject to the state of cleanliness, damage caused or deficiencies in the inventory. In case of departure outside the opening hours of the reception office, your deposit will be sent to you by post, after checking the accommodation. This deposit does not constitute a limit of liability.
2. An incoming inventory will be made upon your arrival. A complete list of equipment with an estimate of the price of each item will be given to you. In case of damage or absence of equipment not detected on arrival, you have 24 hours to report it to reception.
3. An outgoing inventory will be made when you leave. Any damage to the accommodation or its accessories will result in repairs at your expense. In the event that the rental requires cleaning, the necessary time will be charged at the rate of 70 euros per hour, and the amount deducted from the deposit.
4. Our rentals are all equipped with a fridge, hotplate, sufficient crockery, drawsheets and blankets. You must bring your sheets and tea towels as well as your towels.
